



## COCA SHOWCASE FEES

All MUSIC acts MUST apply online at: [www.Sonicbids.com/cocanational](http://www.Sonicbids.com/cocanational)

All other acts (comedy, lecture, variety, etc.) have a choice. They may apply online at Sonicbids or by hard copy submission ONLY IF a website can be provided with sample video. Absolutely NO CD's or DVD's will be accepted as part of a showcase application.

### A. Fees for Acts Applying Through Sonicbids

Any artist selected to showcase must be or become an Associate Member of COCA or be represented at the conference by a company that is or will become an Associate Member of COCA.

If your act applies through Sonicbids and is selected to showcase, please note that the following fees must be received at the COCA office **NO LATER THAN Wednesday, April 14, 2010** or you will lose your showcase spot. For "represented acts", fees from the agency or company representing the act at the Conference, must also be received by April 14<sup>th</sup> or the act will lose its showcase spot.

#### A-1 Self-Represented Acts:

1. Showcase Fee – \$250.00 + \$32.50 HST tax = **\$282.50 CAD**
2. Associate Membership Fee (reduced special artist rate saves 45%) - \$150.00 + \$19.50 HST tax = **\$169.50 CAD**
- 3-1. Conference Fee (incl. shared booth, 1 delegate) – exact amount varies per options on conference registration form – minimum \$280.00 + \$36.40 HST tax = **\$316.40 CAD**

#### OR

- 3-2. Conference Fee (incl. full booth, 2 delegates) – amount varies per options on conference registration form – minimum \$490.00 + \$63.70 HST tax = **\$553.70 CAD**

#### A-2 Represented Acts:

##### From the Artist

1. Showcase Fee – \$250.00 + \$32.50 HST tax = **\$282.50 CAD**

##### From the COCA Associate Member Representing the Act

2. Associate Membership Fee (only if membership expires before June 1/12) – \$285.00 + \$37.05 HST tax = **\$322.05 CAD**
3. Conference Registration Fee (incl. full booth, 2 delegates) – amount varies per options on conference registration form – minimum \$490.00 + \$63.70 HST tax = **\$553.70 CAD**

**B. Fees for Acts Submitting a Hard Copy Application**

For hard copy submissions (only non-music acts), ALL applicable fees must be sent with the showcase application. Aside from the non-refundable application fee and artist membership fee, cheques for the showcase fee and the conference registration fee, will not be deposited by COCA unless the act is selected to showcase

The following “minimum” amounts must be submitted as separate cheques with your hard copy application:

**B-1 Self-Represented Acts:**

Cheque #1 - Non-refundable Showcase Application Fee - \$35 + \$4.55 HST = **\$39.55 CAD**

Cheque #2 - Non-refundable Associate Membership Fee – \$150.00 + \$19.50 HST = **\$169.50 CAD**

Cheque #3 - Showcase Fee – \$250.00 + \$32.50 HST tax = **\$282.50 CAD**

Cheque #4 - Conference Fee (incl. booth & delegate pass)

4-1. Conference Fee (incl. shared booth, 1 delegate) – exact amount varies per options on conference registration form – minimum \$280.00 + \$36.40 HST tax = **\$316.40 CAD**

**OR**

4-2. Conference Fee (incl. full booth, 2 delegates) – amount varies per options on conference registration form – minimum \$490.00 + \$63.70 HST tax = **\$553.70 CAD**

**B-2 Represented Acts:****From the Artist**

Cheque #1 - Non-refundable Showcase Application Fee - \$35 + \$4.55 HST = **\$39.55 CAD**

Cheque #2 - Showcase Fee – \$250.00 + \$32.50 HST tax = **\$282.50 CAD**

**From the Agency or Company Representing the Act**

Cheque #3 - COCA Membership Fee – \$285.00 + \$37.05 HST = **\$322.05 CAD**

Cheque #4 - Conference Fee (incl. full booth, 2 delegates) – amount varies per conference registration form – minimum \$490.00 + \$63.70 HST tax = **\$553.70 CAD**
